

## The NOBLE Registry - PRIVACY POLICY

Being a non-profit international consortium, the NOBLE Registry Privacy Policy (the "Privacy policy") is provided by the Oncidium foundation. This Privacy Policy describes how we may collect, use, and share information that you and others provide us through our websites located at [www.nobleregistry.org](http://www.nobleregistry.org). (the "Website"). This Privacy policy applies only to the NOBLE Registry Website.

### Information Collection

You may voluntarily provide information about yourself when you use certain features of the Website. For example, you may choose to provide us with information when signing up for our newsletter, making a donation (which will also subscribe you to our email list if permitted under applicable law), submitting a fundraising proposal, contacting us, requesting to volunteer, and/or using certain other services and features on our Website.

This may include information such as your name, physical address, e-mail address, ZIP code, billing and payment card information, phone number, date of birth, and country of residence.

If you submit a funding application, or a fundraising proposal, we may also collect information about your proposal, such as the associated company, the personal information of other individuals involved, and your title and contact information. By providing information about other individuals, you represent to us that you have obtained the consent of such individuals to provide such information to us. Please do not send confidential health information to us directly through this Website, or by email to any of the contact email addresses listed on this Website.

We may also obtain personal information from third parties to support our operations, such as when you use the third-party links and tools described further below. Additionally, if you have provided us with information, we may combine it with information from third-party sources.

We may also gather technical information when you use our Website including, but not limited to, browser type, IP address, pages visited and other activities on the Website, online locations that you visited before arriving at the Website, device type, and time and date of visit. We may also receive information about your current location if permitted by your browser settings and we obtain your consent where required by applicable law. We may collect data regarding your interactions with our emails. We (or third parties) may use cookies or similar technology to collect such information for advertising and other purposes. See the "Digital Advertising & Analytics" and the "Your Choices"

sections of this Privacy Policy to learn more about the use of this information and the choices available to you.

### **Information of Use**

We may use the information we collect for any lawful purpose, including, but not limited to, the following:

- ✓ To provide products and services you have requested, including to process payments for donations and to provide communications and newsletters to which you subscribe; in this regard, please note that if you join or donate to the NOBLE Registry, you will be placed on our newsletter mailing list, if permitted under applicable law;
- ✓ To process donations such as a fundraising proposal;
- ✓ To permit you to comment on our blogs, and to provide notifications of follow-up comments if you request such notifications;
- ✓ To respond to your questions, concerns, or requests;
- ✓ To send offers and advertising from us, our affiliates, and third parties, including opportunities to participate in contests and surveys;
- ✓ To operate and improve the Website and our business;
- ✓ To provide and personalize updates, surveys, and other content and communications to you, including to save your Website preferences to personalize future visits to our Website; and/or
- ✓ As otherwise disclosed at the time of collection or use.

### **Information Sharing**

Please see the “Third-party Links and Tools” section below for more information on how third parties may collect personal information in connection with our services.

**Donor Information:** When we collect your name or other personal information through a donation, we will not trade, share, or sell this personal information with any other organization or individual other than as disclosed in this Privacy Policy and in compliance with applicable privacy laws, nor send donor mailings on behalf of other organizations, unless we have the donor’s specific permission to do so. This restriction applies to donor information that we collect offline as well as through this Website.

**How We Share:** If we have collected information through the Website that identifies you individually, we may share this personal information with other parties including:

- ✓ Affiliated companies and organizations, if permitted under applicable law;
- ✓ Service providers or agents that perform activities for us, such as to third-party service providers as needed to process a donation, send our emails or host the Website;
- ✓ Third-party partners engaged in fundraising activities for our benefit (for example, please note that if you donate through an individual fundraiser, including a fundraising appeal in honor or in memory of a specific individual, we may provide your name, message, and contact information to the fundraiser);
- ✓ As part of a corporate sale, merger, acquisition, or other transfer involving all or part of our assets including as part of an insolvency or bankruptcy proceeding or as part of a corporate reorganization or other change in corporate control;
- ✓ Pursuant to a subpoena, court order, search warrant, governmental inquiry, or other legal process or as otherwise permitted or required by applicable Belgian or other law, or to protect the rights, privacy, property, business, or safety of The NOBLE Registry, its partners and

employees, Website visitors, or the public or to investigate a breach of an agreement or contravention of law;

- ✓ As part of an effort to prevent, investigate, detect, suppress or prosecute fraud or criminal offenses or attacks on the technical integrity of the Website or our network; or
- ✓ With your consent or as otherwise disclosed at the time of data collection or sharing.

We and our third-party service providers and affiliates may be located in Belgium or other jurisdictions and may maintain and process your personal information in such jurisdictions.

### **Digital Advertising & Analytics**

We may partner with social media tools, ad networks and other ad serving providers (“Advertising Providers”) that serve ads on our behalf on non-affiliated platforms. These Advertising Providers may use tracking technologies (including cookies and pixel tags) on our Website and other sites and apps in order to serve these ads. Some of those ads may be personalized, meaning that they are intended to be relevant to you based on information Advertising Providers collect about your use of the Website and other sites or apps over time (such as web pages you visit and your interaction with our advertising and other communications), including information about relationships among different browsers and devices. This type of advertising is known as interest-based advertising.

If you delete your cookies or use a different browser or mobile device, you will need to renew your opt-out choices. Your opt-out only applies to the web browser you use so you must opt-out of each web browser on each device that you use. Note that opting out will not stop advertising from appearing in your browser or applications. It may make the ads you see less relevant to your interests. Additionally, your browser may offer tools to limit the use of cookies or to delete cookies; however, if you use these tools, our Website may not function as intended.

We may also work with third parties that collect data about your use of the Website and other sites or apps over time for non-advertising purposes. The NOBLE Registry uses Google Analytics and other third-party services to improve the performance of the Website and for analytics and marketing purposes. ### **Third Party links and tools**

The Website may provide links to, or otherwise integrate and share functions with, third-party websites or apps, including our social media pages, clinical trial services, social media fundraising appeals, and other fundraising tools. These third parties may share the personal information that they collect with the NOBLE Registry. We do not control the privacy practices of those websites or apps, and they are not covered by this Privacy Policy. You should review the privacy policies of other websites or apps that you use to learn about their data practices.

The Website may also include integrated social media tools, such as social networking, photo sharing, and video streaming tools offered by third parties. If you use these tools to share personal information or you otherwise interact with social media features on the Website, those social media companies may collect information about you and may use and share such information in accordance with your account settings on that social media platform, including by sharing such information with us or the general public. Your interactions with third-party social media companies and the use of their features are governed by the privacy policies of the social media companies that provide those features. We encourage you to read the privacy policies that apply to any social media accounts you create and use.

## **Safeguarding Information**

We maintain – and we ask any third-party partners that store information on our behalf to maintain – reasonable administrative, technical, and physical safeguards for personal information collected through the Website. These safeguards are designed to protect the personal information we collect against theft; loss; misuse; or unauthorized access, disclosure, alteration, or destruction. Our service providers are given the information they need to perform their designated functions, and we do not authorize them to use or disclose personal information for their own marketing or other purposes.

We reserve the right to use any information previously obtained to verify your identity in connection with your access request or to take other actions that we believe are appropriate and lawful. We will endeavor to comply with your request as soon as reasonably practicable. To the extent permitted by applicable law, we may decline to process requests that are unreasonably repetitive, require disproportionate technical effort, jeopardize the privacy of others, are impractical, or for which access is not otherwise required by local law. Please note that we may need to retain certain information for recordkeeping purposes, and that residual information may remain within our databases and other records and will not be removed from such locations. We are not responsible for removing or deleting information from the databases of third parties that we do not control with whom we have shared information about you prior to your request.
